Each lodge will select a winner, using the criteria listed above. The lodge will notify winners. Winning posters will be forwarded to the District Chairperson for the District Level Competition. District winners will be forwarded to the State Level Competition. All winning entries become the sole property of the Benevolent and Protective Order of Elks and may not be returned.

This winning poster will be submitted for entry into the annual National Elks contest and for inclusion in the Elks DAP Coloring Book.
